COME NOW the parties, by and through counsel, and file this Joint Status Report to the Court, as directed by this Honorable Court on April 18, 2017.

The parties have been working cooperatively on coming up with a solution to the issues identified by Plaintiffs in their complaint. Specifically, the Defendants are in development of a

new assessment tool for determining eligibility and service levels for in-home services and the parties have discussed the Defendants' plans and progress to date. Defense counsel has given Plaintiffs' counsel access to the consultants who have been retained by Defendants to develop the new assessment tool and service levels, and several productive question and answer sessions have been held.

Based upon the ongoing cooperation between the parties, Plaintiffs are asking this Court to continue the stay for a period of six months. Neither the answer nor a response to Plaintiffs' motion for class certification need be filed during that time. However, the parties reserve the right, upon 30 days written notice, to reinstate litigation on this case prior to the end of that six month period should they deem it necessary.
